As the Electoral Officer for the Sagkeeng First Nation Chief & Council Election Process, please find enclosed forms that are required for Phase I of the Electoral Process. You should find enclosed 4 documents which include:

- 1) A notice of the Nomination Meeting which includes the date, time and location
- 2) A mail-in nomination form, should you choose to nominate a candidate(s) for a Chief, a Councillor or for both
- 3) A mail-in voter declaration form and
- 4) An address release form.

If it is your intention to nominate a candidate(s), please fill out the mail-in nomination form along with the mail-in voter declaration form that must be signed and witnessed. If you choose to nominate more than one candidate, then separate forms (**both the nomination & declaration forms**) must be submitted for each of the candidates. Please feel free to copy the forms, as needed.

You also have the option of authorizing the release of your name and address which will be provided to all election candidates for the purpose of receiving campaign literature only. To do this, simply fill out and sign the bottom portion found on the Notice of Nomination Meeting.

Please send all your forms to the address below and note that all nomination documentation must be received prior to the start of the nomination meeting.

Once all the nominees have been declared, you will be receiving a mail-in voting package.
