ADVANCE POLL: Sunday March 31, 2019: 8am to 8pm at the North Shore, Sagkeeng High School.

MAIL-IN BALLOTS: Voters who meet criteria for mail-in ballots (Section 86 a., b., or c.) must complete Form F and send it to the Electoral Officer. Deadline to request mail-in ballots is March 18, 2019

1. Voters must bring government/ Sagkeeng issued identification in order to vote (preferably photo identification).
2. The Sagkeeng Members Voters List will be available at the Sagkeeng Band Office (204) 367-2287 . Off reserve members can call toll free 1-866-878-2911. Voters can submit a Form G if their name is not on the list.
3. Voters wishing to receive information from the Electoral Officer or from the candidates must fill in a Form D (authorizing the Electoral Officer to provide their address to the candidates) and forward their addresses or emails to the Electoral Officer.

! Notice – Sagkeeng Nominations Meeting!

February 12, 2019 4pm to 8pm

Sagkeeng High School: North Shore

Nominations for Executive Council will be held according to the Kakekanawok Onakonigawin /Election Law: 6 persons elected as Councillors and 1 person as Chief.

Eligibility of Electors; (part 1; section 6) An Elector (a Member of Sagkeeng First Nation who is 18 years of age on the date of the election) may nominate or second only **one** candidate for each position. Electors must submit a nomination on Form B. When an Elector nominates a candidate, they must make a statement to those present why they are nominating that person. If Electors cannot attend the meeting, they can send in a nomination Form B to the Electoral Officer but it must be received no later than the day before the nomination meeting (Feb 11, 2019)

Eligibility of Candidates:(part1; section 8 a-e) A candidate must be a member of Sagkeeng First Nation; must be 18 years old as of election day; must be properly nominated and seconded; must submit a nomination Form B; and must produce a clear criminal record check and a clear child abuse registry check that does not date back any further than July 31, 2018. A candidate must only be nominated for one position. Upon accepting the nomination, the Candidate must make a statement to those present why they are accepting and must describe their qualifications, education (traditional and academic) or experience. If unable to attend, Candidates must send written, signed, and witnessed confirmation to the Electoral officer before the close of the meeting. All candidates must have their candidacy accepted by the Electoral Officer.
